Parish Council (PC)

Heidi Frary (Clerk)

A report from the unconfirmed minutes of the 18 November meeting held via Zoom.

Councillors: Tim Birt (TB – chairing), Dave Welsted (DW), Jeremy Woods (JW) and Karen Weir sends apologies.

Meeting suspended at 7.35pm to allow Re-Evolution make a presentation.

Representatives of Re-Evolution explained that they are a group of six families working together to develop community and sustainable projects. They have taken responsibility for some land in Ovington behind Dairy Farm to form a carbon neutral market garden. Activities include regenerative farming, food security and water management.

It is hoped that planning will be submitted to create structures for a community space and hub including temporary housing for those workers, a forest school and yoga retreats. So far an entry road and gate have been installed. It is hoped that eventually it will become a national scheme and will reduce food miles across the country.

There were questions and it was noted that there are no fixed plans as yet, however Breckland are being engaged at all stages in the process.

Meeting resumed at 7:45pm

Matters Arising

Allotment Entrance. TB reported that he has contacted the Allotment Association and evaluation work is underway however due to lockdown restrictions and the weather it has been delayed.

Use of COVID-19 grant for hardship fund. TB reported that whilst the grant cannot be used for individuals, there is the opportunity to provide community support.

Correspondence

NCC: Parish Partnerships Scheme. A resident has requested the extension of the trod, however there are not sufficient resources for this to be considered for this financial year. It will be considered for a future round of bidding.

Planning

<u>3PL/2020/0086/O</u>: Land at Church Farm: erection of 6 self-build residential dwellings (APPEAL). It was agreed that the existing comments still stand and no further submission is necessary.

<u>3PL/2020/1142/F</u>: Ruxley House, Carbrooke Road – change of use from garage to ancillary living accommodation (retrospective). It was felt acceptable as long as it is energy efficient and a restriction is included that the ancillary living accommodation be only used in conjunction to the main dwelling, not as a separate rented dwelling.

Accounts & Administration

Councillors agreed payments (full details on website) and reviewed our financial position relative to that predicted in the precept calculation.

Updates to the Sickness Management Policy, Tree Management Policy and Filming at Council Meetings Policy documents were approved.

Village issues

TB reported that the request for ditches to be cleared has resulted in much work being undertaken and the basic flooding that has been seen in the past has been resolved. Cross drainage is still a potential issue and will be reviewed after the next heavy rain.

TB has reported a dead animal and fly-tip to Breckland Council, they resolved the matter within 24 hours.

The rusted Give Way sign in the Parish should be repaired in the next few weeks.

Adjournment for public participation

County Council

 CC Bowes reported that council officers have met with the Cranswick Incident Management Team and positive results are low. An Avian Flu protection is now present in the UK and whilst there are no cases in Norfolk, there are strict regulations in place to avoid any spread.

District Council

 DC Crane reported that Breckland Council has received the RSPA Award for the fifth year in a row an award for its outstanding work with animal welfare, particularly in the area of stray dogs. The Council has recruited an Animal Welfare officer, which is a new role at the Council. The officer will be employed to carry out visits and inspections at licensed premises.

- Any resident who is isolating can contact the council for help, isolation grants are available and Breckland Council will be processing these.
- A £6 million support package has been launched to help the district's businesses through lockdown. Claims can be made through the Council website.
- The Council response for the second planning white paper has been returned.
- The Council is no longer using the district valuer. A private company that does work only for councils is going to do valuations for planning purposes. She hopes this will give much more confidence to residents regarding valuations that are done when S106 obligations are removed or affordable housing requirements lowered.

He brought this fun to village hall and allotment events, devising games and entertainment to bring everyone together. Only Steve could persuade people out of their seats to join in with fun and games. His priority was always to ensure others had a good time. Even during his illness, Steve was still mowing the Village Hall and Church grass.

He will be greatly missed by the village hall committee, on the allotments and throughout the village. When current restrictions are lifted, there will be a large celebration at the village hall of his life. In the meantime, our thoughts and condolences are with Sue and the family.

The funeral (restricted to family only) will take place on Thursday 26 November at 12 noon – the procession will begin from the village hall at 11.35 – but will be webcast live for those unable to attend.

Avian Flu

There are confirmed cases of avian influenza H5N8 in poultry and captive birds in the UK.

Bird flu is a notifiable animal disease. If you suspect any type of bird flu in poultry or captive birds you must report it immediately by calling the Defra Rural Services Helpline on 03000 200 301.

If you keep poultry, whether commercially, or as pets in your garden, you should keep a close watch on them for signs of disease and maintain good biosecurity at all times.

Flocks of 50 or more must be registered, keepers of smaller flocks are strongly encouraged to register in order to keep updated with regulations and requirements which also apply to garden birds.
